# Methodology and Sample

The Civic Data & Research Institute conducted a likely general election Florida voter survey of n=1,001 using a probability-based online panel.

Respondents were selected through random sampling methods designed to ensure that every individual in the target population had a known, non-zero chance of selection. The panel was recruited and administered online. The data were weighted using iterative raking techniques to align with the latest Florida voter file benchmarks for age, gender, race/ethnicity, education, and region. These weights adjust for any differences between the sample and the Florida voter population to ensure representativeness.

The survey has a margin of error of  $\pm 3.1$  percentage points at the 95% confidence level. This margin accounts for the expected range of sampling error in survey estimates based on a sample size of n=1,001.

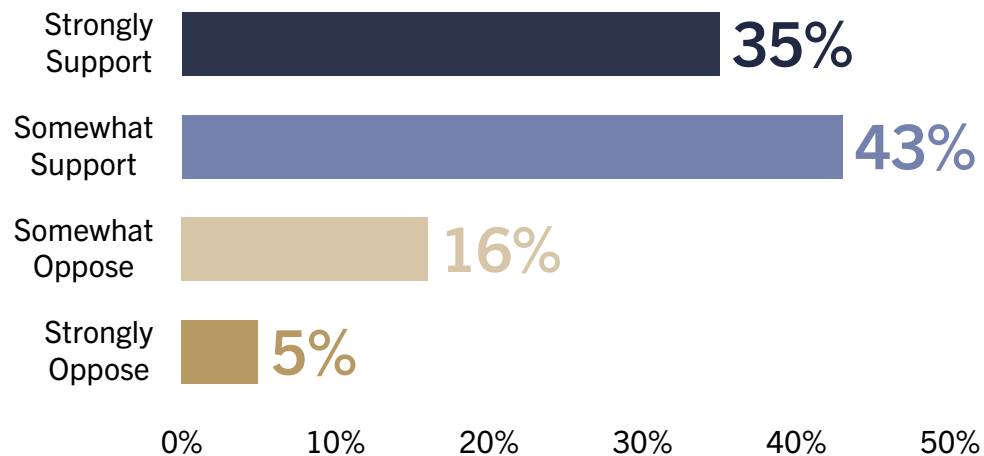

### HB 657



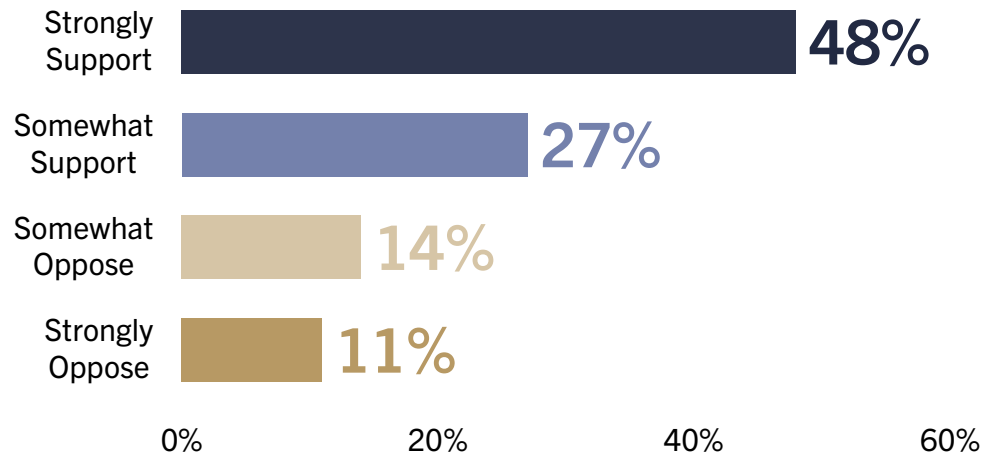

### SB 1052

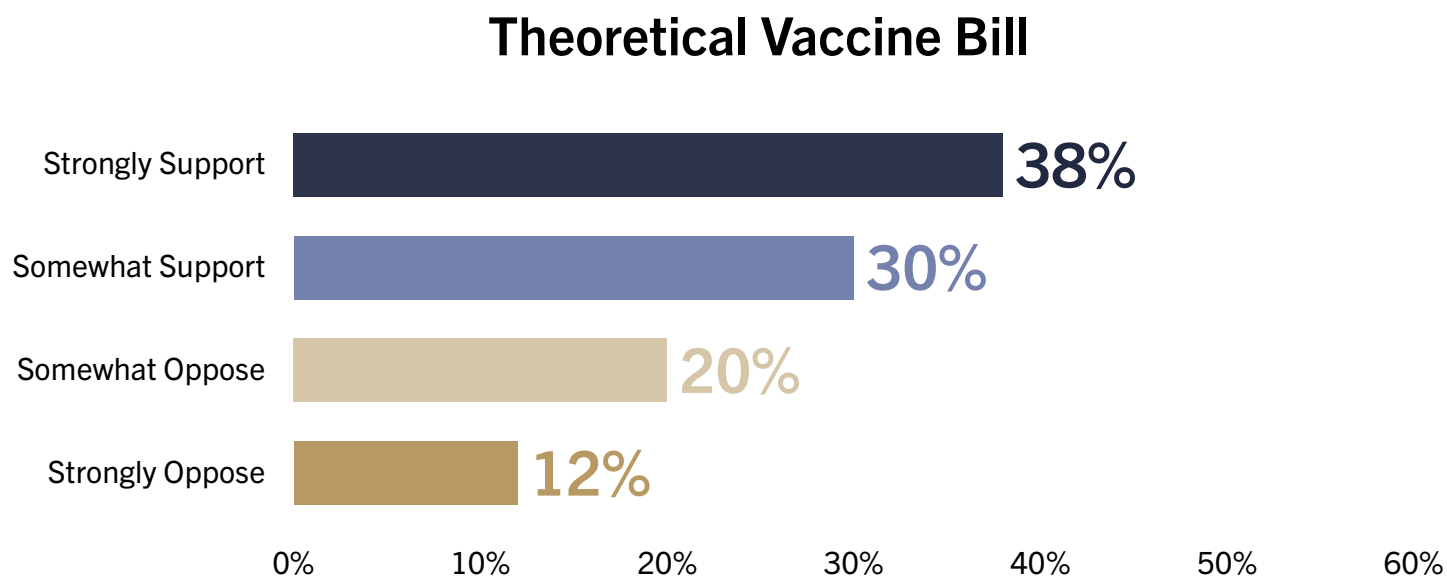

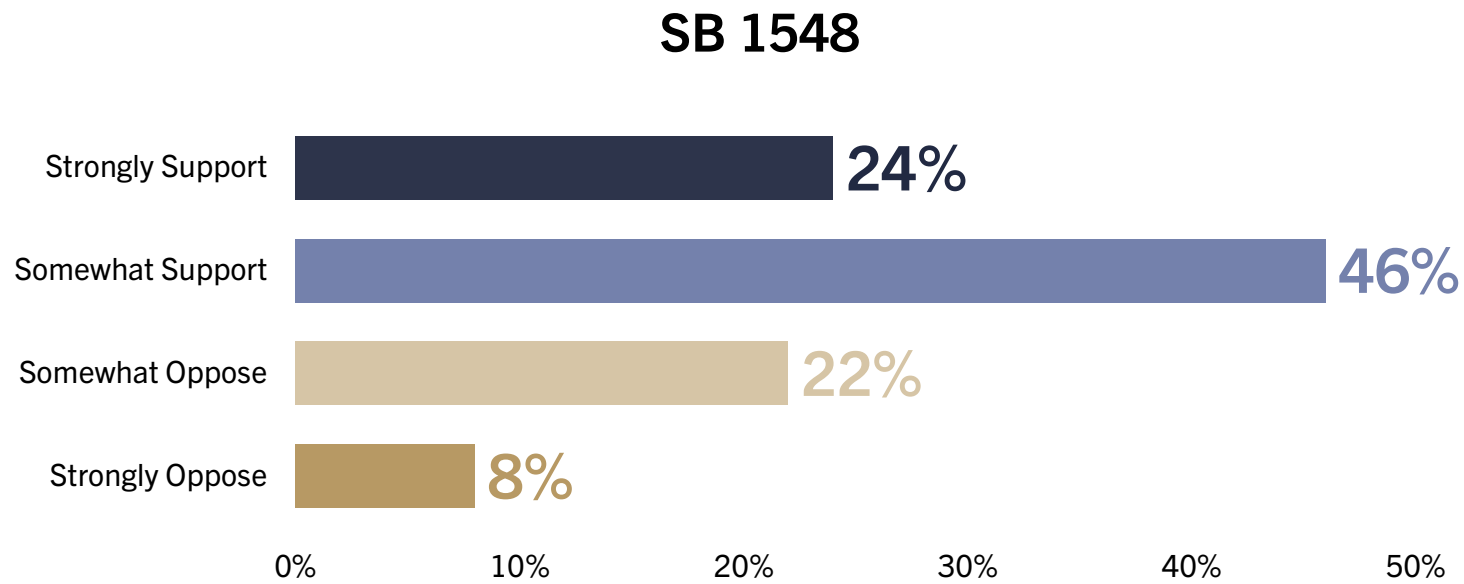
## 68 percent of voters support giving parents greater authority over childhood vaccinations

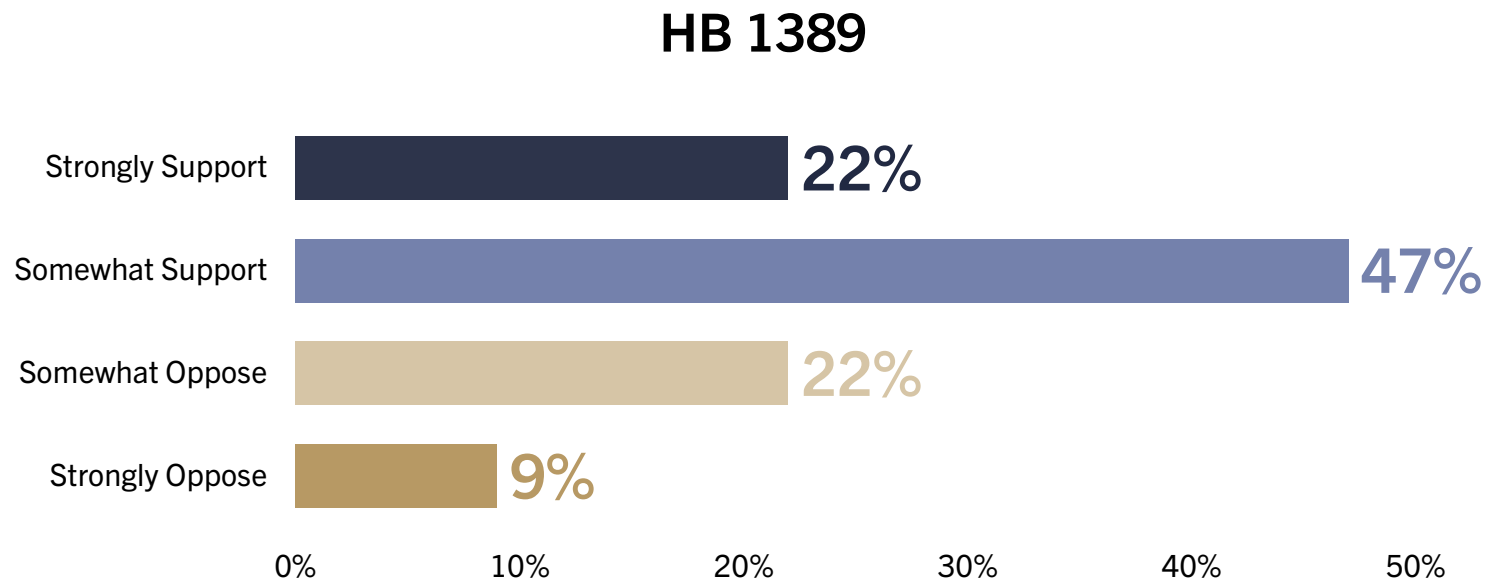
## Support for SB 1548 exceeds opposition by 40 points
